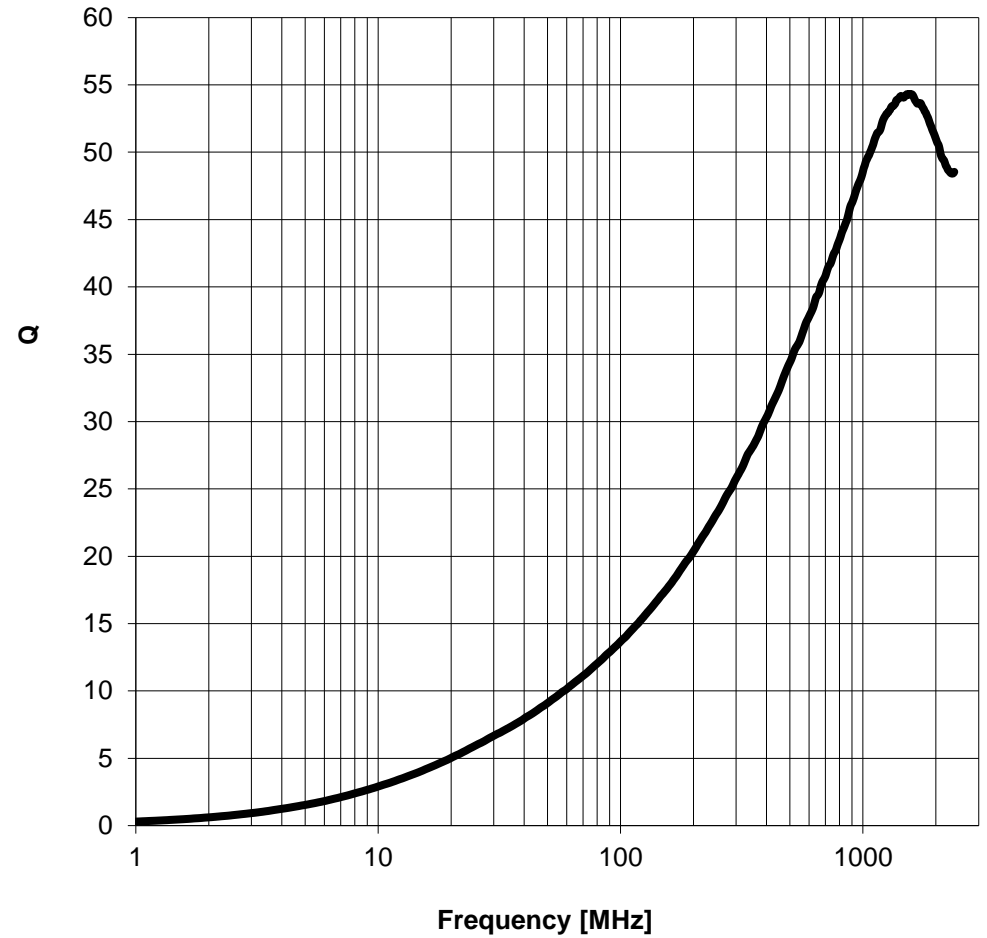

### Q-Factor vs. Frequency:

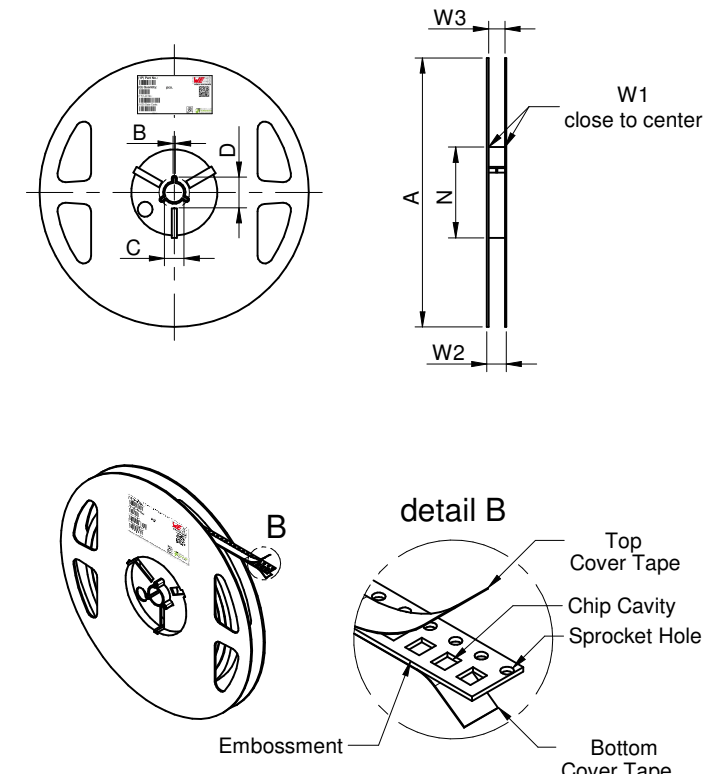

#### Soldering:


