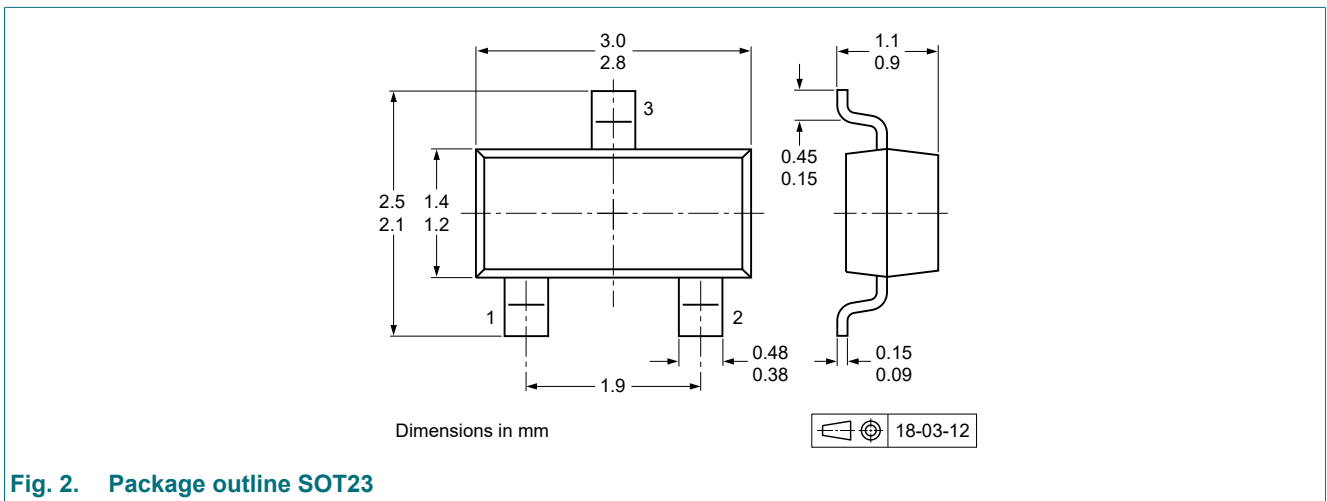

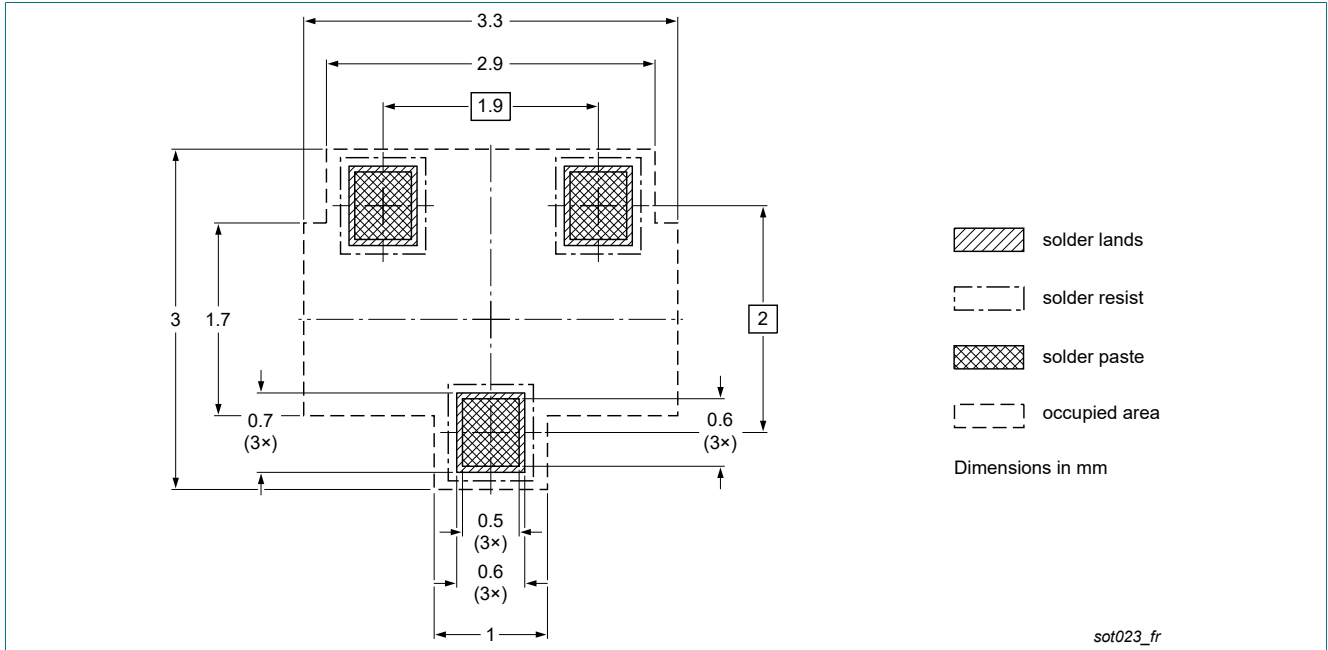


Fig. 3. Reflow soldering footprint for SOT23

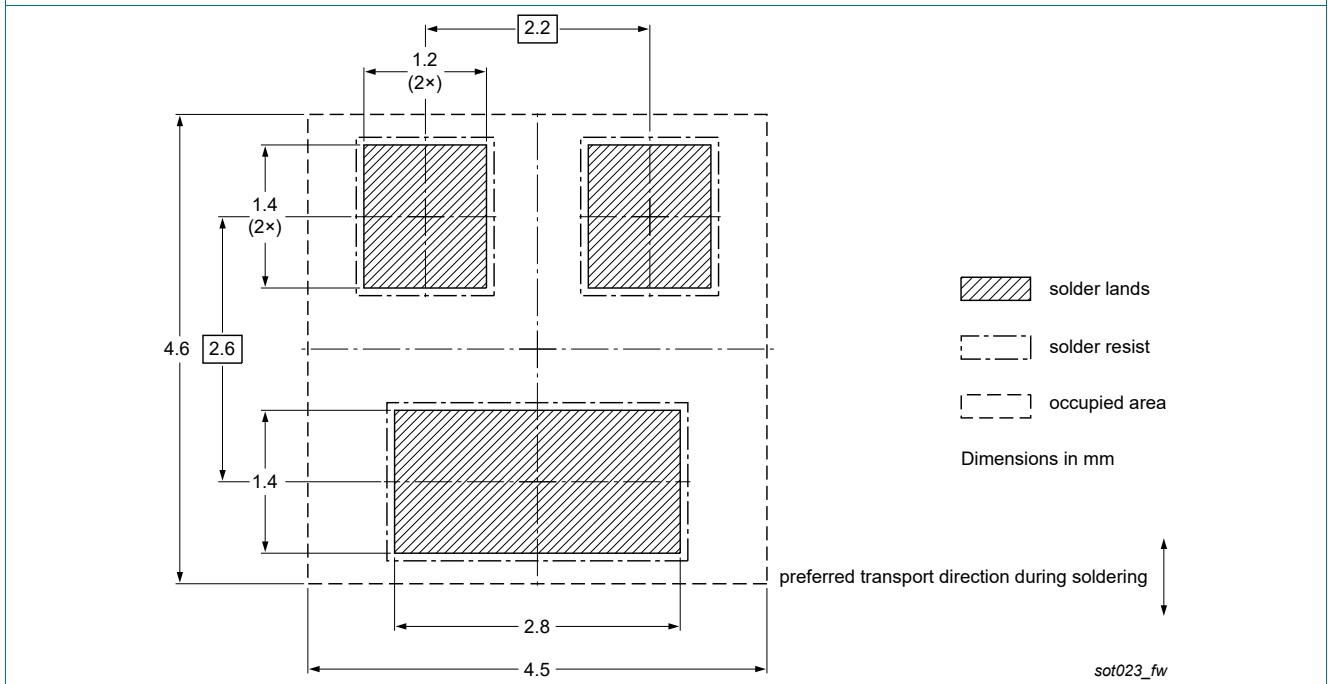


Fig. 4. Wave soldering footprint for SOT23
