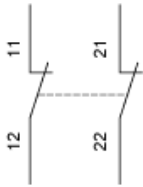
Position of Cable Gland

2-pole NC + NC Snap Action

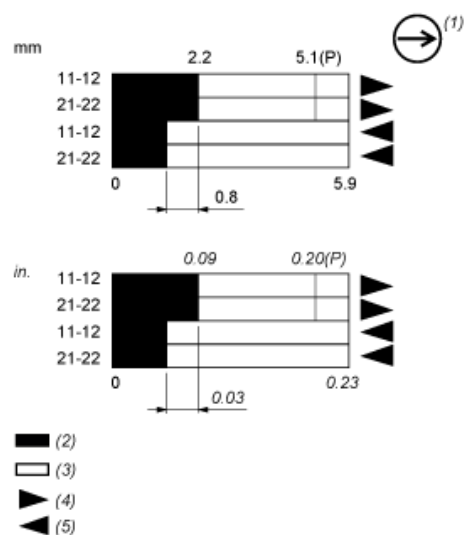


Characteristics of Actuation
