Expand marking on 1971779, 1971787 and 1971237 to include a wire size indicator. No change to other terminals. Modify the wire range note to indicate the CMA range on all customer drawings. This change is considered by TE Connectivity to be minimal as it only affects the markings.

Reason for Changes:
Customer Request. Wire size indicator on the terminal allows for easier identification after crimping. Showing CMA on the Customer drawings provides additional clarification.
