### 2. Background for production discontinuation

All our radial lead type products of φ20 and φ22, characteristic of special equipment in production with special specifications, have been deleted from the 2015/2016 Edition Catalogue because of their decreasing demand with the progress of miniaturization and high performance of high CV products. As we could not secure stable supply of such products due to small production quantity of several thousand pieces per month, aging of equipment and difficulty in securing materials, we decided to put the production to an end.
