### Typical Insertion Loss:



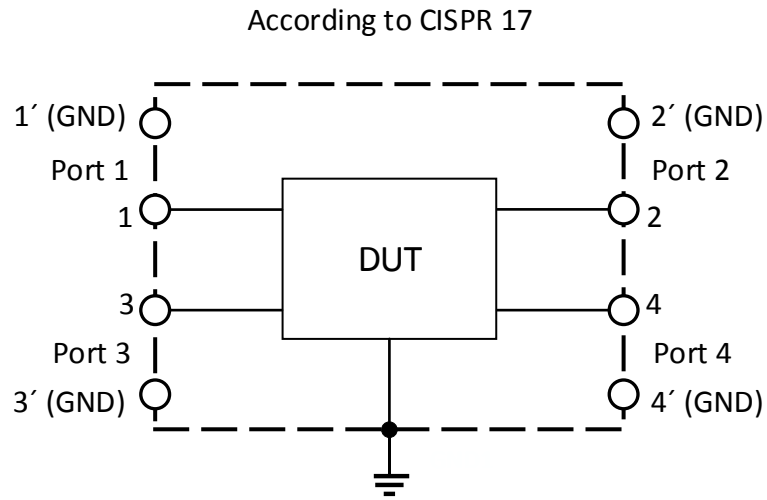

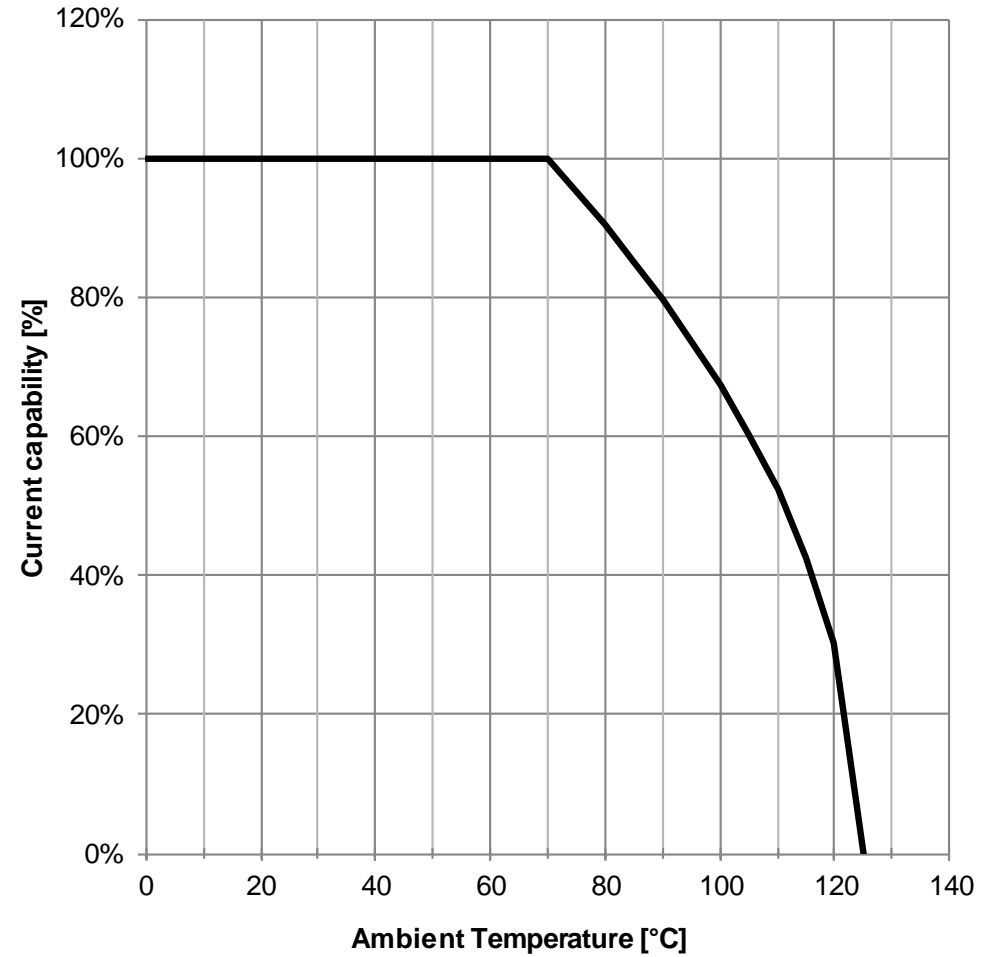

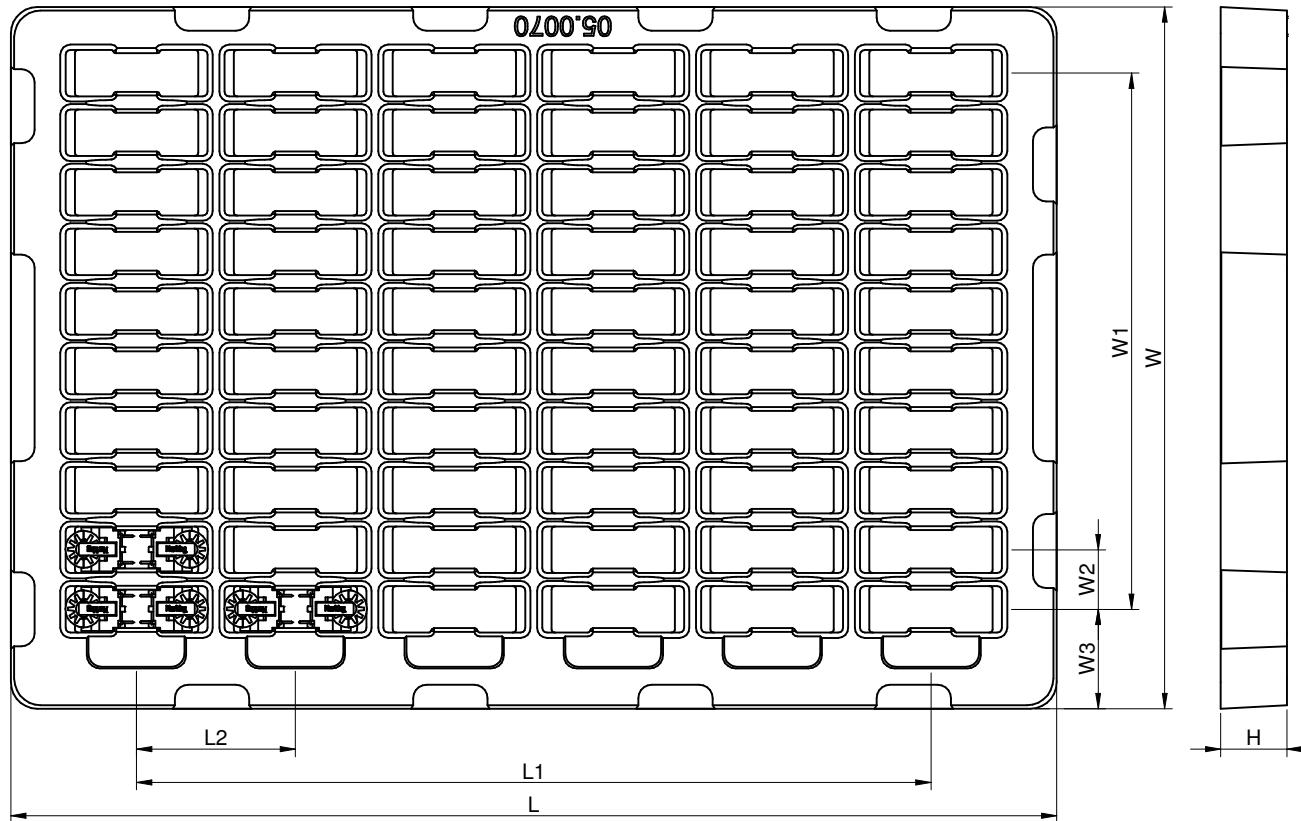

## Derating Curve:

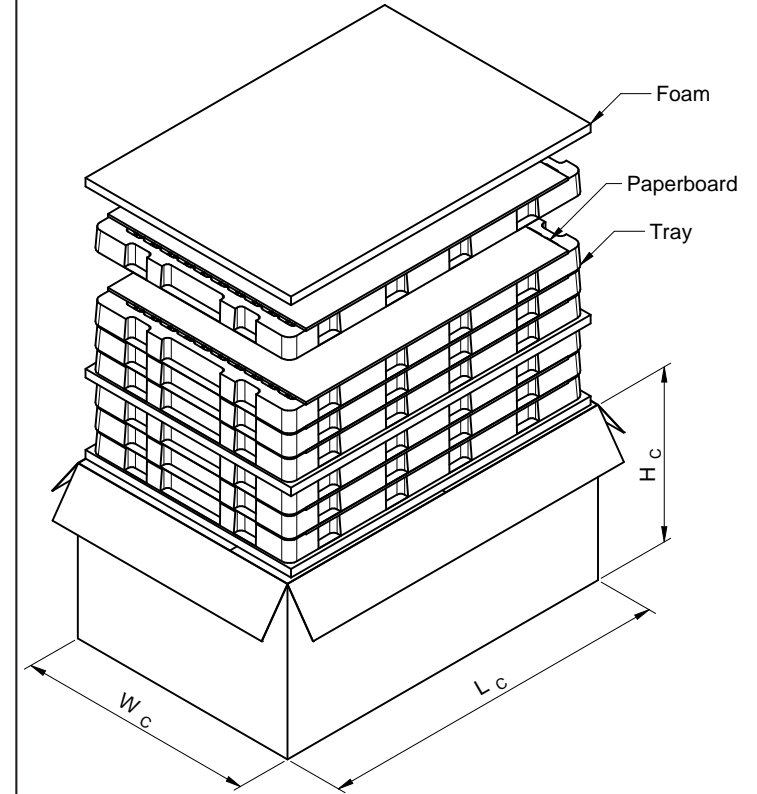

#### Soldering:



## Storage Conditions:


