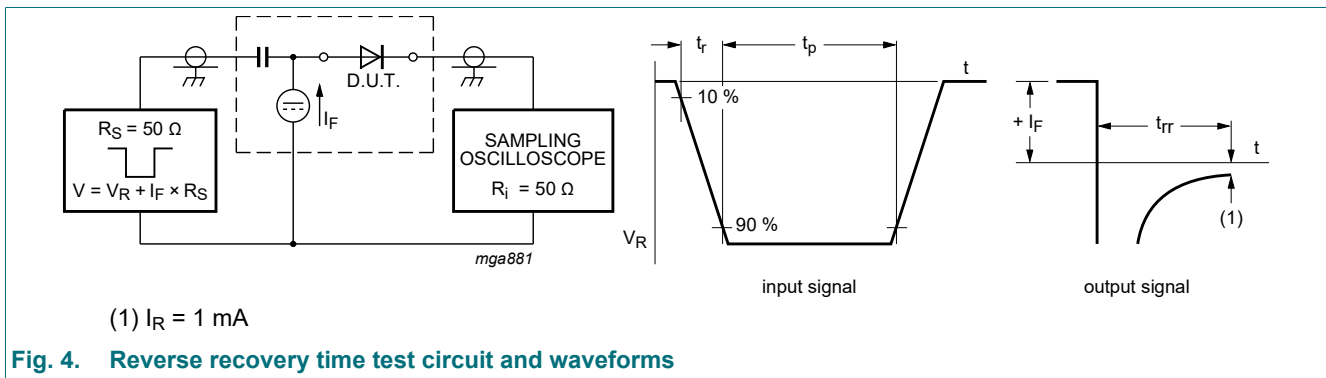

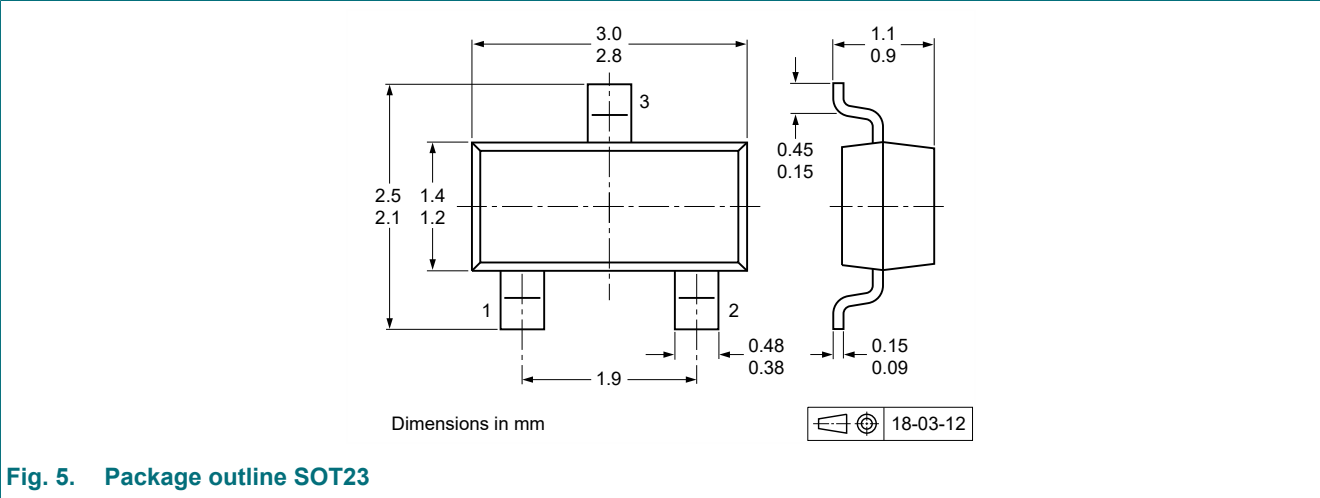


Fig. 5. Package outline SOT23
