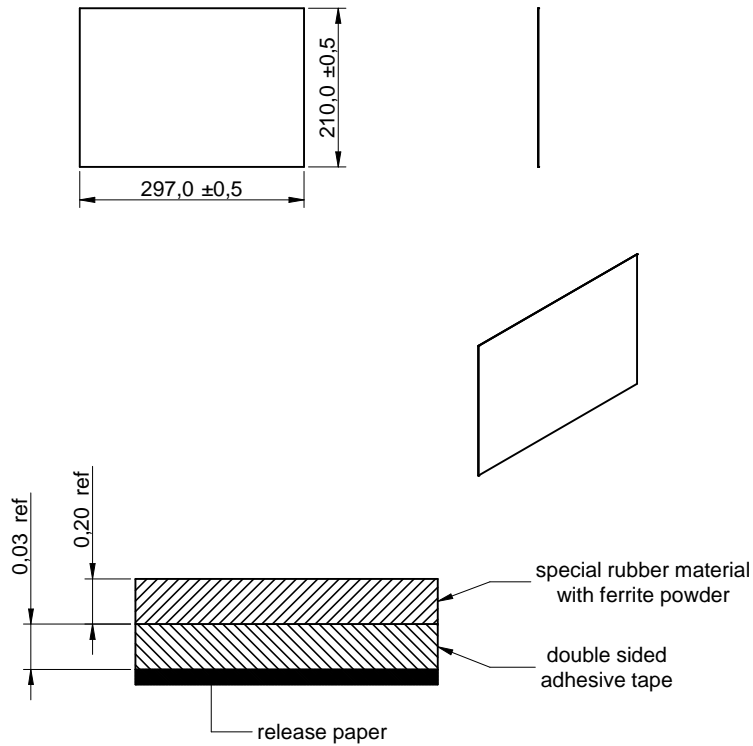

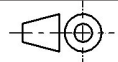

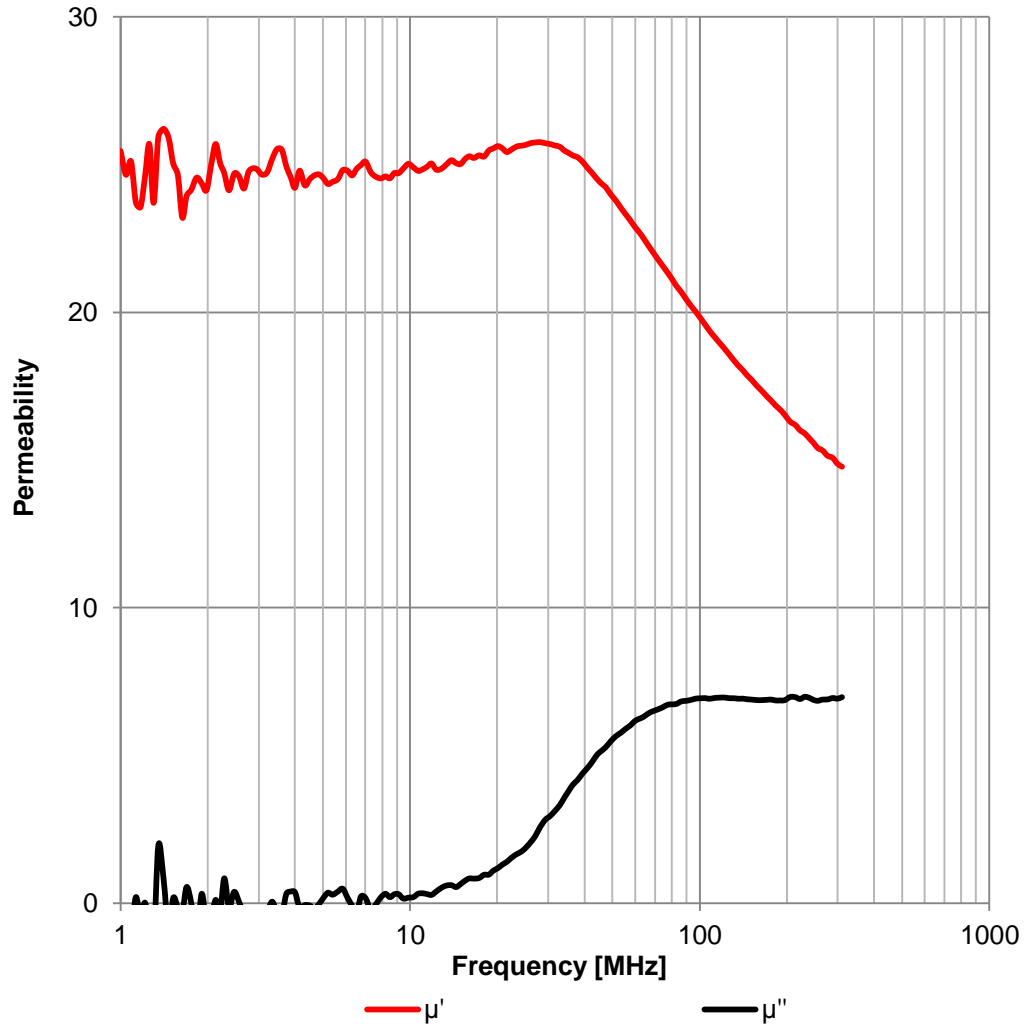

## Permeability vs. Frequency:



### 6. Product Life Cycle

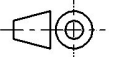
