Micron recognizes the importance of restricted substance control and accuracy of reporting chemical composition in the automotive industry. PCN 34601 was issued to inform customers that a new lead-frame vendor had been onboarded because of supply constraints. The composition of the lead-frame is Nickel (Ni), Palladium (Pd) and Gold (Au), and the composition of the lead-frame in Micron products has not changed. The PCN incorrectly indicated that lead-frames also contain a reportable amount of Silver (Ag) in the composition. The Title and Description below have been updated to remove this reference to Silver (Ag).

Micron's existing reporting for the part numbers below is correct and no changes will be made. If you are not currently receiving chemical information in IMDS, please request IMDS reporting through the normal Micron process.
