- Ceramic SAVVI Packaging Change.
 - Ceramic SAVVI Chip Antenna with Mxxxxxx part numbers ship as standard 1,000 pcs per tape and reel packaging.
 - Ceramic SAVVI Chip Antenna with Mxxxxxx-10K part numbers ship as special order 10,000 pcs per tape and reel packaging.
 - Ceramic SAVVI Chip Antenna with Mxxxxxx-01 part numbers ship as Chip Antenna SMT mounted on Demo Boards.

Each of the components new part numbers will be 100% compatible with the original part numbers for each of the components for their physical dimensions and their RF performance.

New parts will be rolled out one part number at a time starting in June 2016.
