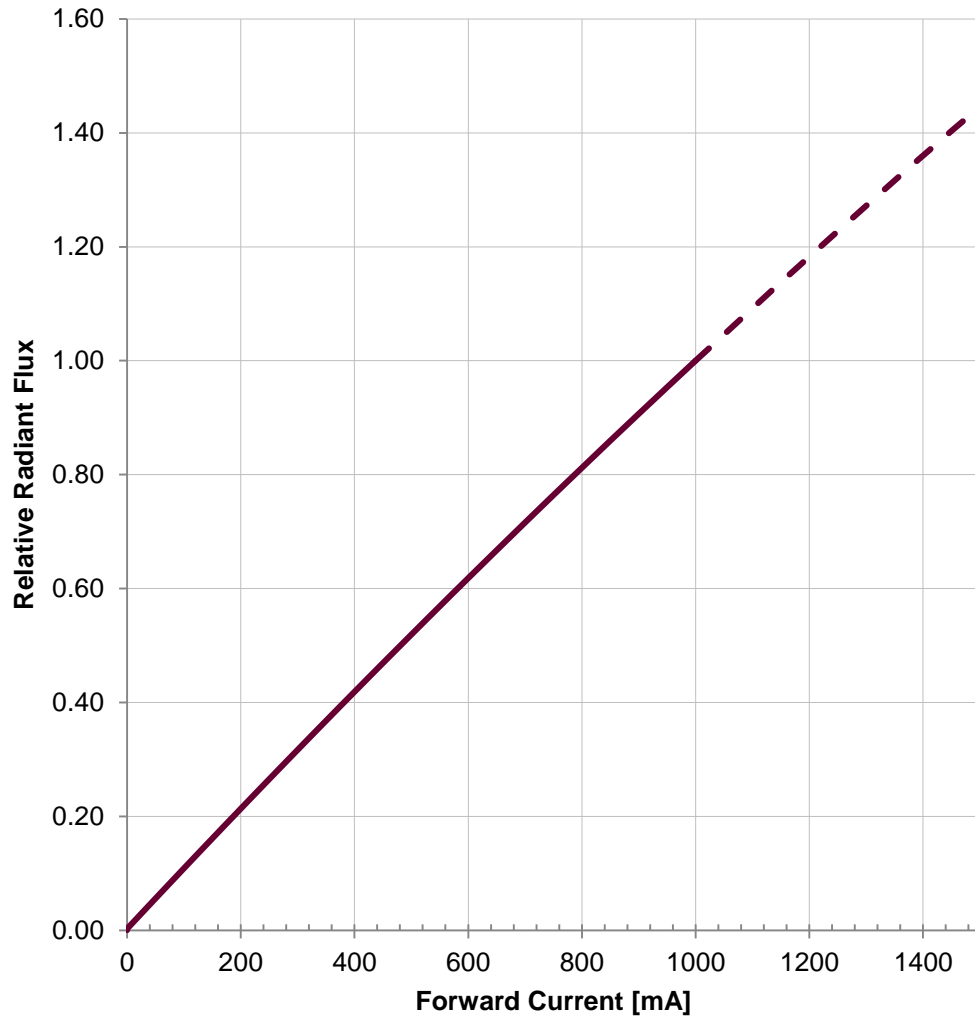


## Forward Current vs. Forward Voltage:

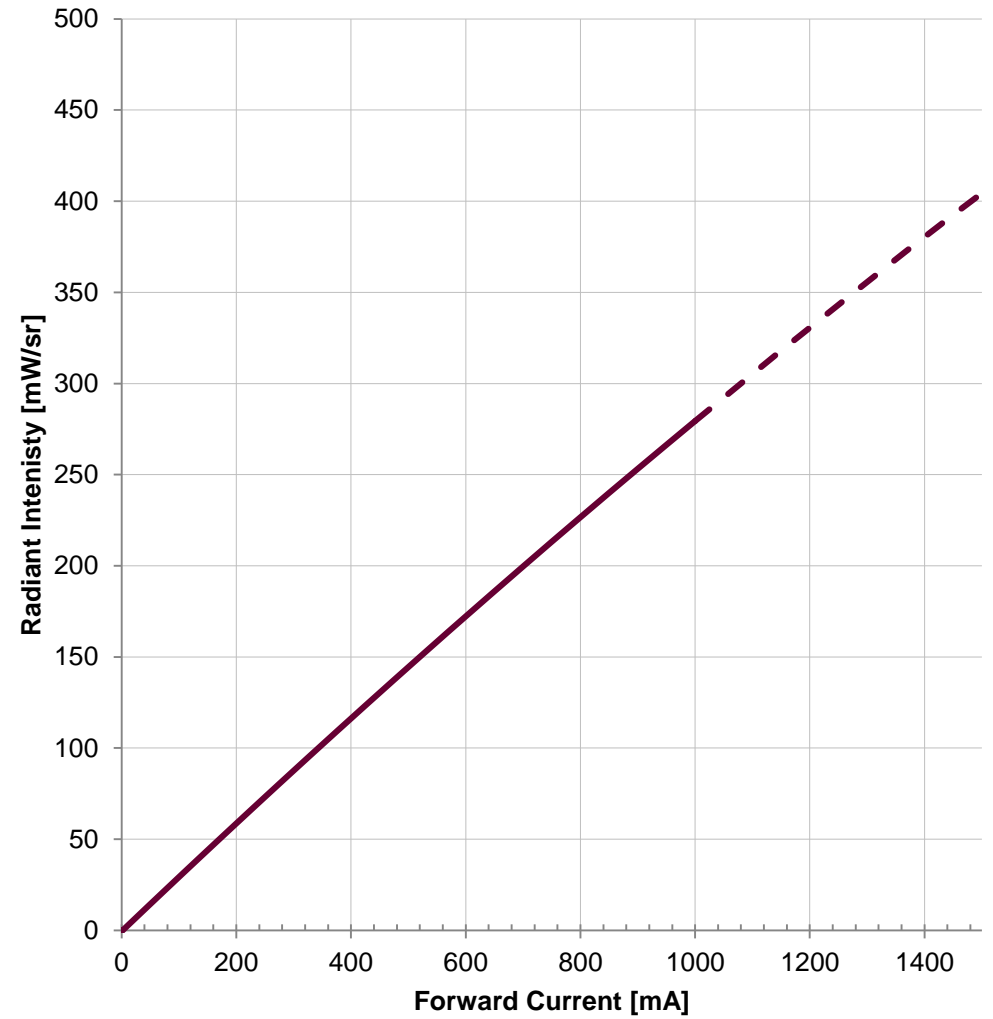

### Radiant Intensity vs. Forward Current:

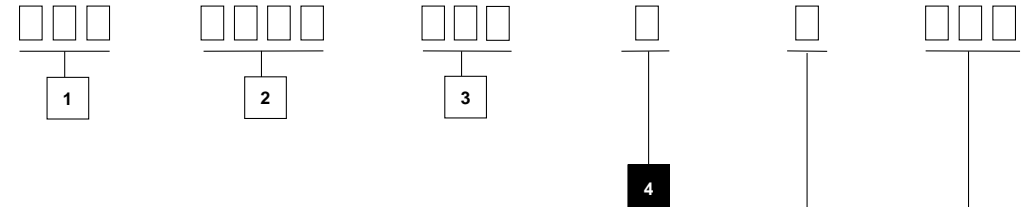

#### Soldering:




