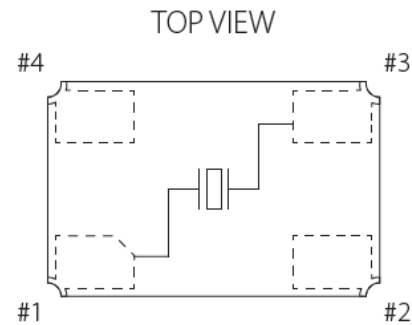
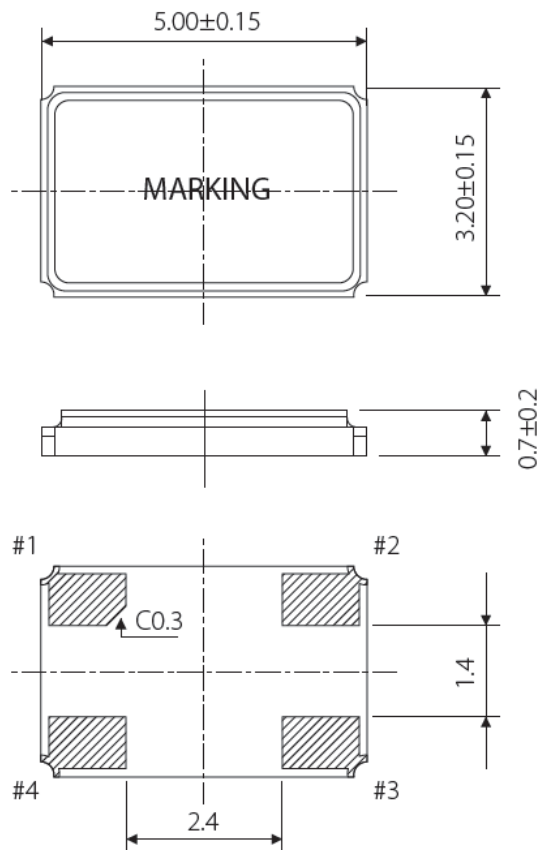

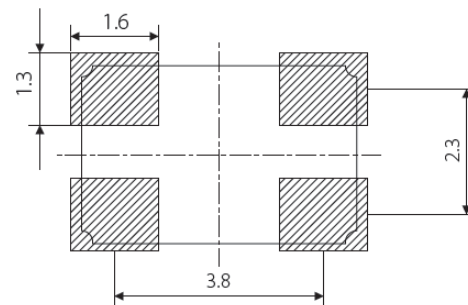
Mechanical Dimensions

Reflow Profile [JEDEC J-STD-020]

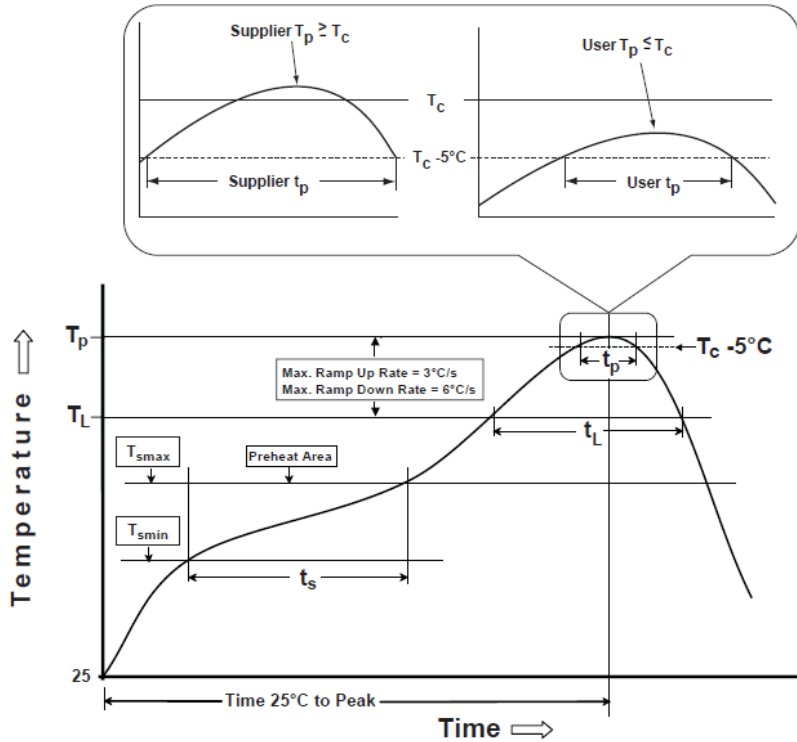

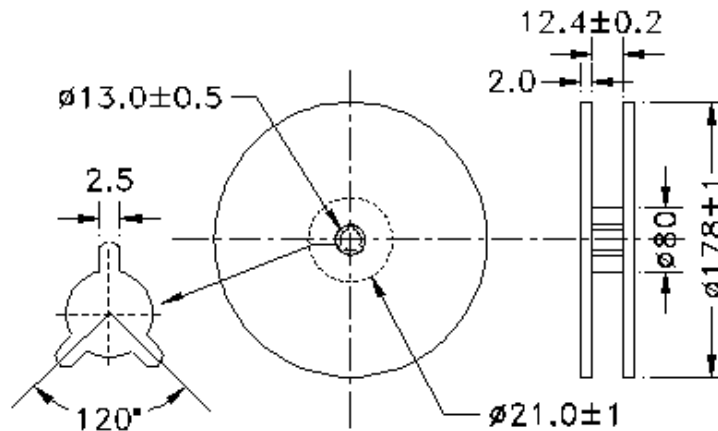
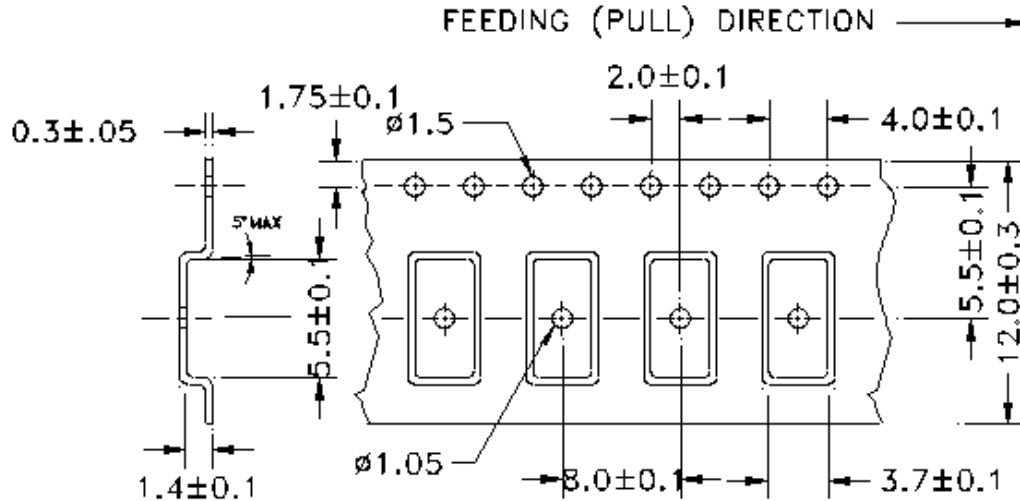
