**Description of Changes**

Housing raw material change, Manufacturing location and new tooling change. Following Part Number's manufacturing location will be changed from Shen Zhen to TE Qingdao China. The raw material of housing changed from PA 66 to PA 6. The new parts are made from new tools.

**Reason for Changes:**

Product Improvement.
