

# 74HC20-Q100

Dual 4-input NAND gate

## 1. General description

The 74HC20-Q100 is a dual 4-input NAND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.

## 2. Features and benefits

- Automotive product qualification in accordance with AEC-Q100 (Grade 1)
  - Specified from -40 °C to +85 °C and from -40 °C to +125 °C
- Wide supply voltage range from 2.0 V to 6.0 V
- CMOS low power dissipation

  - MM JESD22-A115-A exceeds 200 V (C = 200 pF, R = 0 Ω)

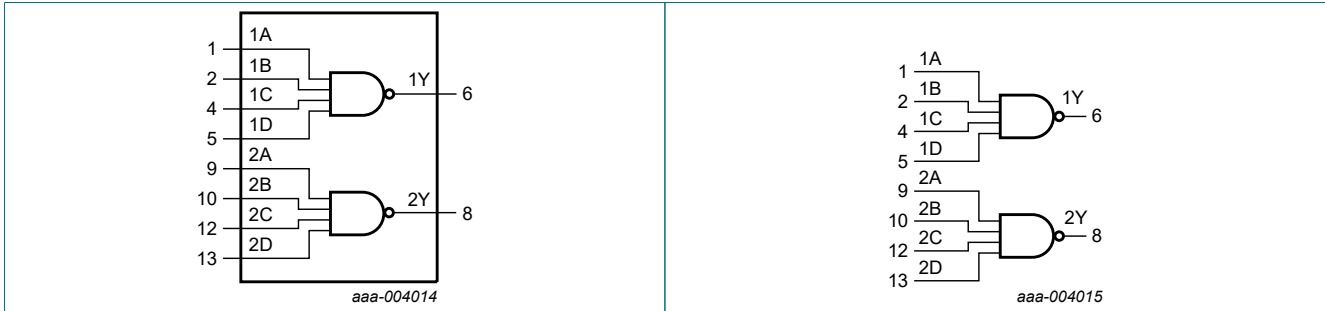


Fig. 1. Functional diagram

Fig. 2. Logic symbol

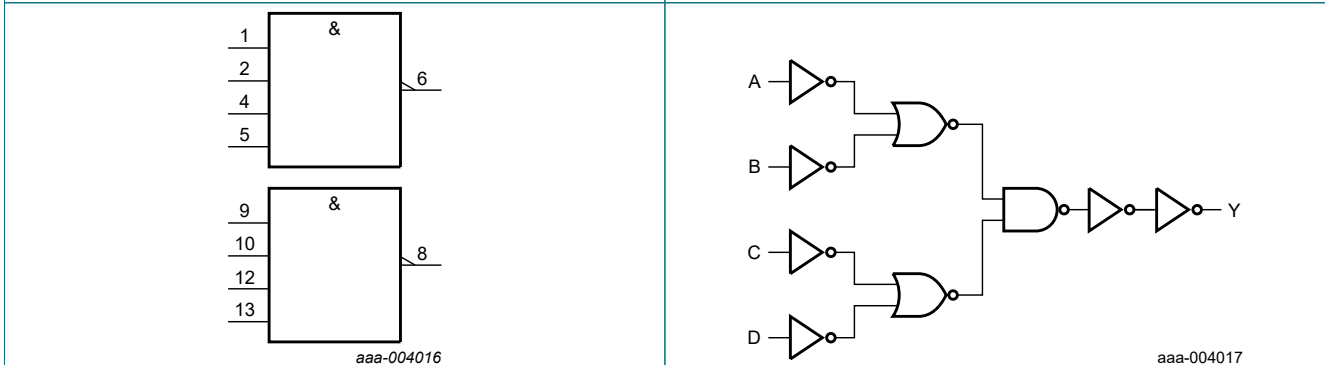


Fig. 3. IEC Logic symbol

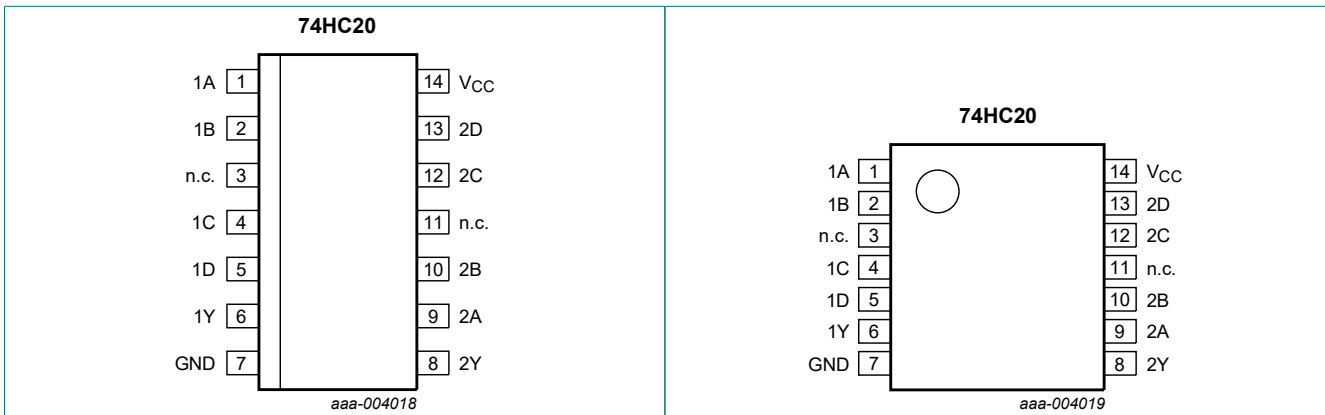


Fig. 5. Pin configuration SOT108-1 (SO14)

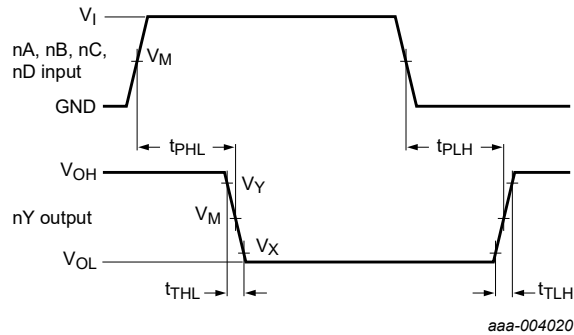

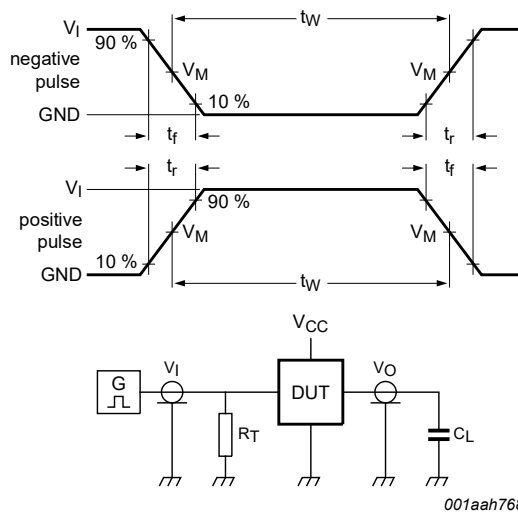

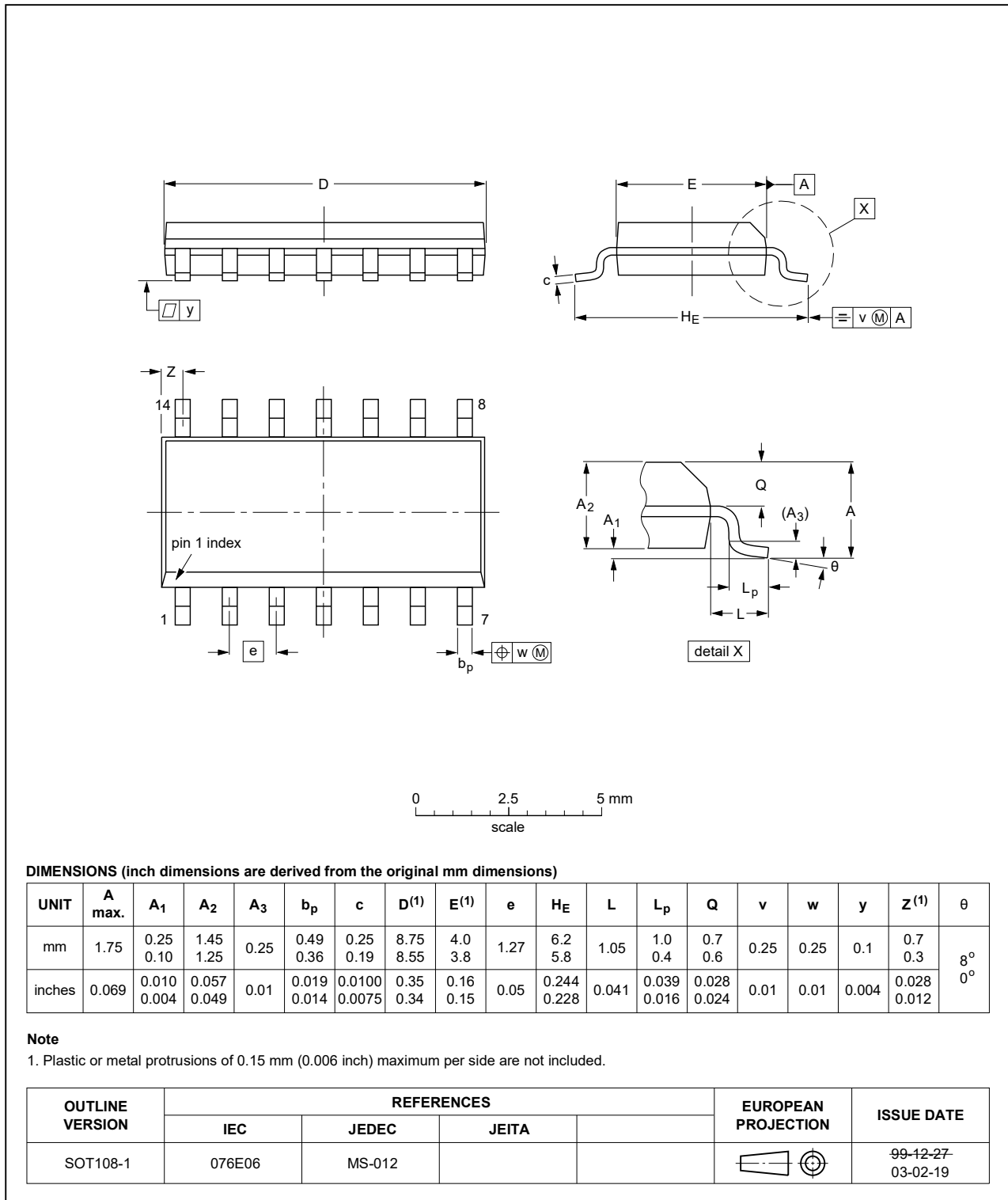


Fig. 9. Package outline SOT108-1 (SO14)

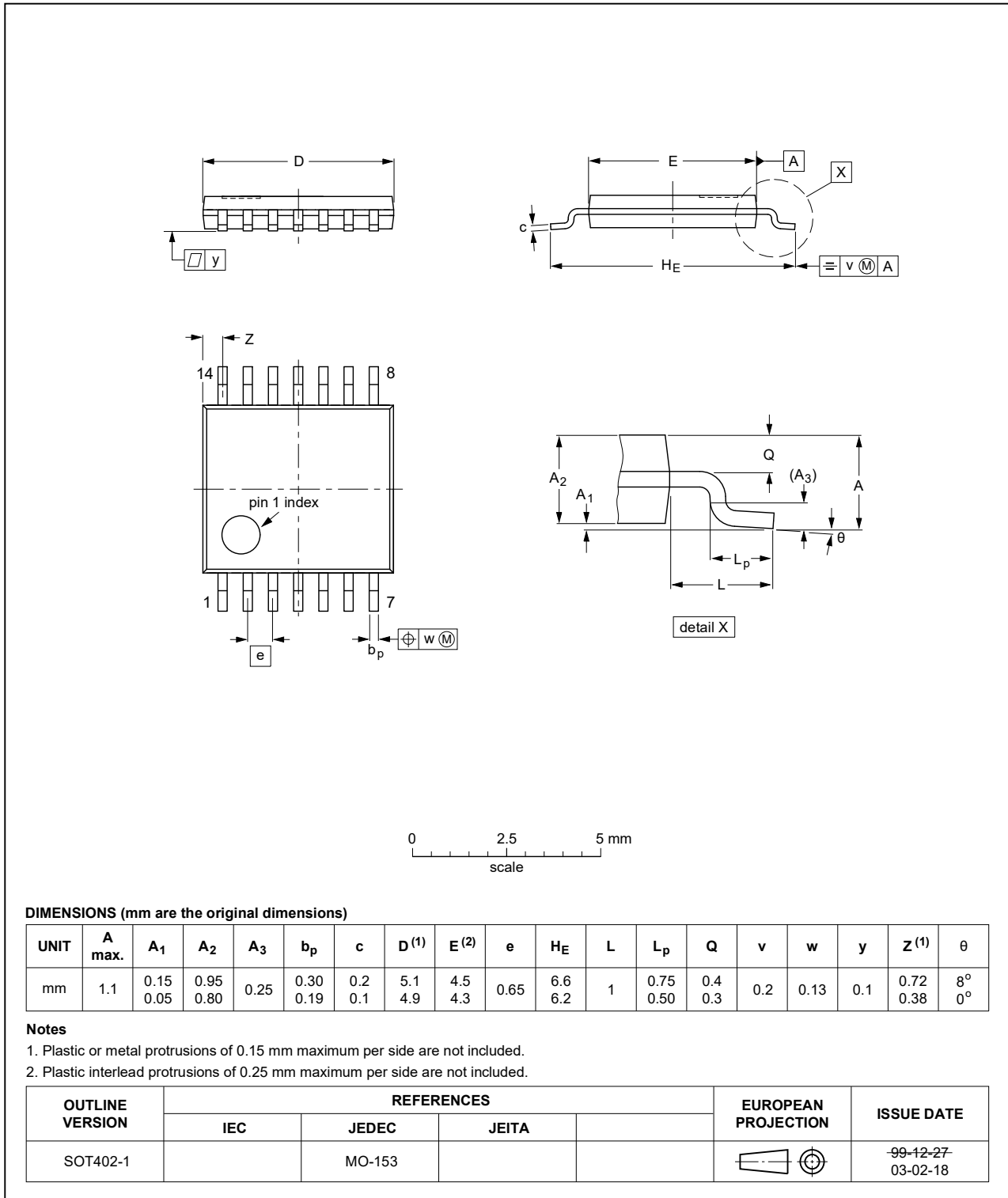


Fig. 10. Package outline SOT402-1 (TSSOP14)
